Order Details & Accuracy:

•The Client is expected to have accurately entered or communicated all pertinent information at the time the order is placed. We reserve the right to update incorrect information and adjust the pricing of the order to accurately reflect the order (ex. The client enters that the property is 1,200 square feet but it is actually 2,400 square feet).

•Our pricing reflects the cost for a single dwelling in a residential household. For commercial or multiunit properties, please contact ust for a personalized quote.

Reschedule/Cancellation Policy:

•Confirmed appointments canceled or rescheduled within 8-24 hours before the appointment start time are subject to a \$50 cancellation fee. If the apointment is rescheduled for a new apointment time within 2 weeks of the ooriginal appointmet time the \$50 cancellation fee is wived.

•Confirmed appointments canceled or rescheduled within 8 hours before the appointment start time are subject to a \$50 cancellation fee plus the trip fee if aplicable.
